- 1. To take efforts for solid waste management by adopting appropriate methods. To develop a segregation protocol for the segregation of different type of solid waste. Organic and biodegradable waste to be collected seperately.
- 2. Recycling and reuse practice to be followed strongly wherever possible.
- 3. Good housekeeping to be ensured throughout the premises for removal of waste.
- 4. Leakages and corrosion of pipes, overhead tanks to be repaired and maintained promptly.
- 5. E-waste segregation, handling and disposal to be done properly.
- 6. Electricity consumption to be controlled and minimised by adopting appropriate practices. Use of LED lamps/tube lights to be encouraged.
- 7. To take efforts for use of solar energy wherever feasible as alternative or additional energy resourse, to save electricity consumption.
- 8. Water management program to be implemented on campus for optimum utilisation of water. To determine the efficiency of water use and to identify opportunities to make water use more efficient.
- 9. To adopt practise of rain water harvesting and collection of roof top water harvesting for the use of water for gardening.
- 10. To reduce water consumption by raising awareness in students & staff members and having periodic check on leaks.
- 11. Drinking water to be tested for the water parameters according to prescribed standards and appropriate appliances and water purifiers to be used for providing safe and potable drinking water to staff and students.
- 12. To follow eco-friendly and sustainable practices to manage the available resources.
- 13. Visual signage boards for generating awareness about conservation of water and electricity and green policy to be displayed in the college premises.
- 14. To create awareness amongst staff, students and society, about environmental pollution and need for protection of environment for sustainable development, by organising various curricular, co-curricular and extra curricular activities.
